Citation Reviews

A safety citation issued by Washington State Department of Labor & Industries (L&I) notifies an employer of Division of Occupational Safety & Health (DOSH) inspection results including any violations found, penalties, and correction dates.

Archbright's *Citation Review* evaluates the severity of the citation and then recommends appropriate next steps during a phone consultation. Our team is also available for ongoing support should you request additional correction time from L&I or decide to appeal the citation.

Online Resources

Available through mozzo, Archbright's members-only app, employers can stay on top of their workers' compensation claims using the Claims Tracker. There are also a number of resources available 24/7 through the Resource Library and Video Training Library to help keep your workplace in compliance and safe.

Noise Level Survey

Noise-induced hearing loss is one of the most common work-related injuries in the United States. The intensity and duration of exposure are critical factors in evaluating the potential for employee hearing loss. Noises above 85 decibels are considered hazardous.

If you are concerned about the noise levels in your workplace, Archbright can help with our *Noise Level Survey* service. We come onsite to determine if your workspace reaches 85 decibels in an 8-hour weighted average. Our consultant collects representative samples over a workday or shift, audits your company's personal protective equipment requirements, and completes a workstation review. Additionally, we make recommendations on any next steps that may be required.

Ergonomic Assessments


When workplace conditions and job demands match the worker's capabilities, safety and productivity improve. Ergonomics is about designing the workplace to reduce risks of strains, sprains, and other musculoskeletal injuries.

Archbright can conduct an *Ergonomic Assessment* of your employees' practices that are associated with their work activities. This includes an observation period in common work areas to review ergonomics across multiple work environments, such as offices or the warehouse floor.
